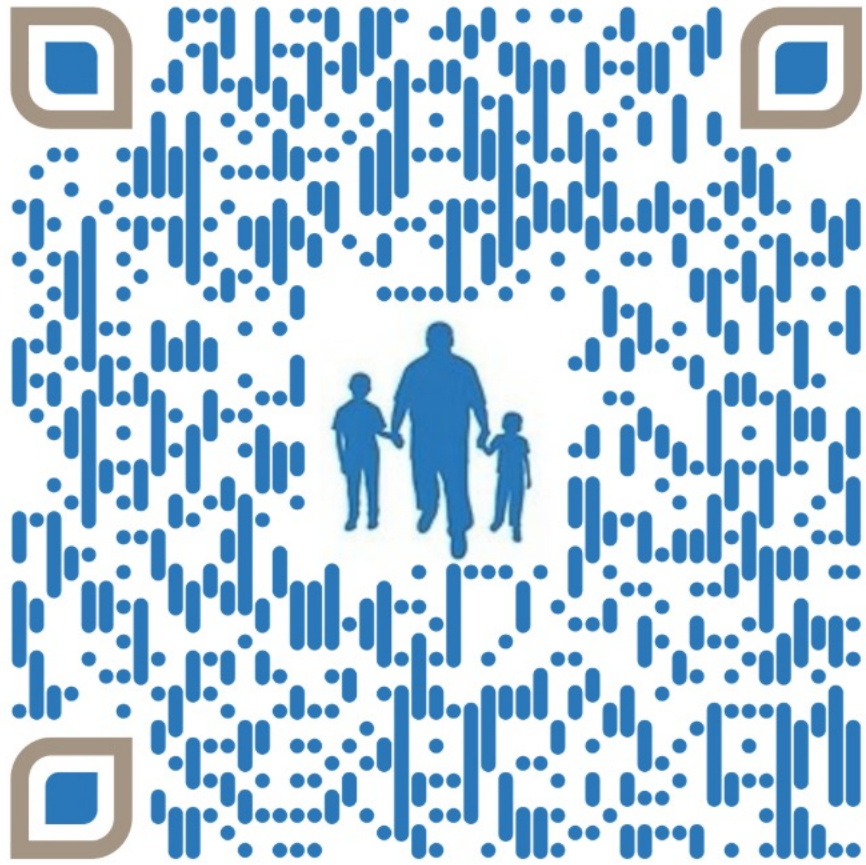

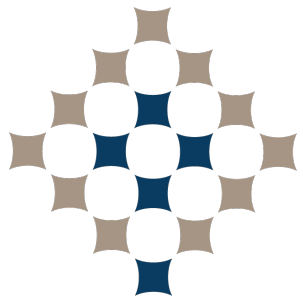

Federal Group Tax Exemption - 501(c)(3)

- CGGC is a Tax Exempt Organization or 501(c)(3) with the IRS
 - Related entities can apply under the CGGC group exemption process
 - If approved as part of the Federal Group Tax Exemption (FGTE), you are federally tax exempt from all “related business income”
 - Unrelated business income is NOT tax exempt
 - Annual process to renew your 2026 participation with CGGC due by 5/4/26
 - Organizations who want to join and obtain their 501(c)(3) status through CGGC, can apply anytime during the year

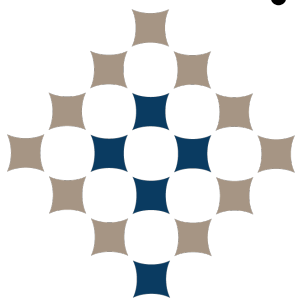

Federal Group Tax Exemption – Why Join?

- Being a 501(c)(3) non-profit organization helps with the following:
 - Non-profit grants
 - Documentation for banks and financial institutions of your status
 - Vendors give price breaks and/or tax exemption with proof of 501(c)(3)
 - Techsoup, Adobe, other software vendors
 - Donations received are tax deductible
 - MATCHING GIFTS available from employers/organizations to registered 501(c)(3) organizations thru programs such as:
 - Benevity
 - YourCause
 - Bank of America, Verizon, Kohls, other national employers
- Avoids the cost and process of applying directly to the IRS
- Half of ERC churches/organizations already participate



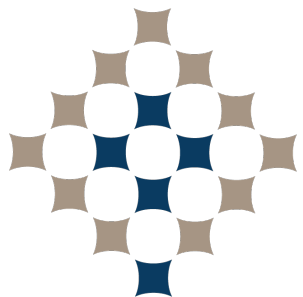

Federal Group Tax Exemption – How to Join?

- Complete an application online or by mail (see CGGC table)
 - Submit your Incorporation documents and constitution/by-laws for review
 - Not incorporated? Submit your constitution/by-laws for review
 - Contact CGGC Treasurer, Kathy Bishop, with questions 419-424-1961 x 119 or treasurer@cggc.org
 - Application is reviewed and Treasurer will follow up with any questions

After you're approved, renew each year after you receive an email by the due date and submit any updates to your incorporation and/or constitution/bylaws

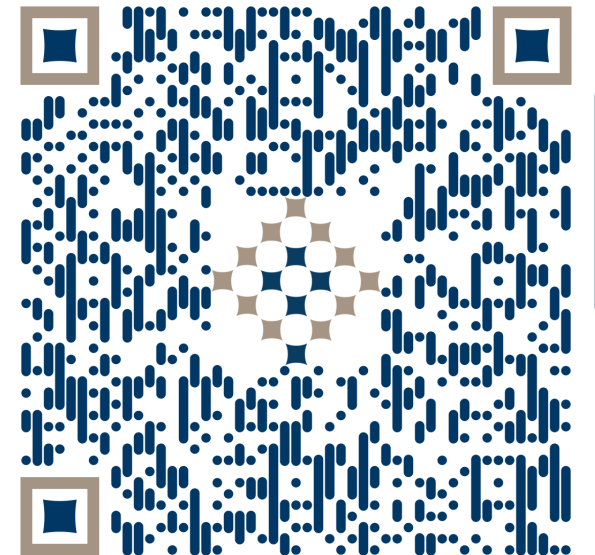

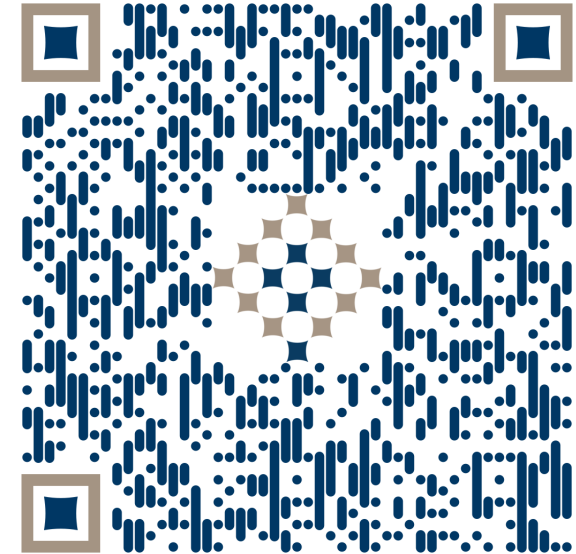

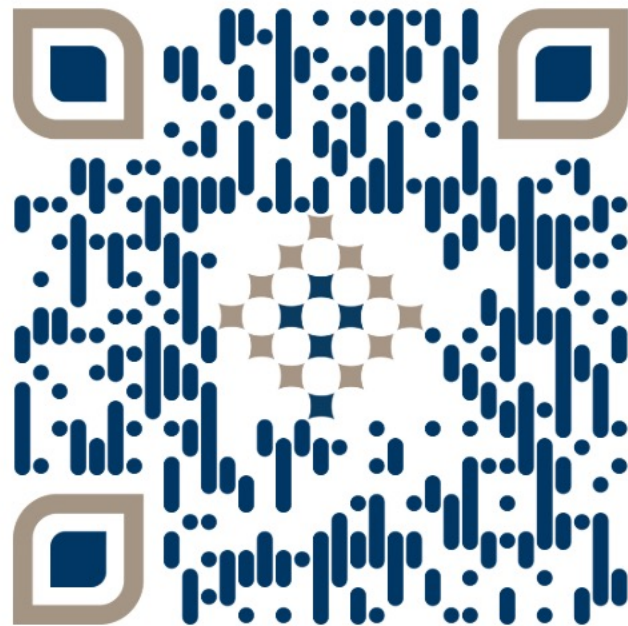
